OFFICE MEMORANDUM

Subject: Mandatory publication of tender enquiries by Ministries/Departments on the Central Public Procurement Portal

This Department vide O.M dated 30th November, 2011 & Secretary (Exp)'s D.O letter dated 12th December 2011 had issued instructions to all Ministries/Departments on the mandatory publication of tender enquiries on the Central Public Procurement Portal (CPP Portal).

2. On review of the e-publishing implementation progress, it has been observed that instructions communicated vide above references to all Ministries/Departments are still to be fully complied with. In this context, the following are highlighted for necessary action/compliance:

- i. Ministries/Departments were requested to send a quarterly report in respect of number of cases in which exemption has been granted from mandatory e-publishing owing to confidentiality along-with the value of the concerned contract. This information was to be sent on e-mail id [cphp-doe@nic.in](mailto:cppp-doe@nic.in) . Similarly, vide OM dated 5th March 2012, all Ministries/Departments were requested to send information on the total number of tenders published on the CPP portal as well as details of contracts awarded thereon at the aforesaid e- mail address by 15th April, 2012. This information is also awaited from Ministries/Departments and can be sent in the following format;

- ii. Further, all Ministries/Departments vide Secy. (Exp)'s D.O. letter dated 12th December, 2011 were requested to send Annexure I, II and III duly filled to mail IDs

cPPP-doe@nic.in and cPPP-nic@nic.in. A list of Ministries/Departments which are yet to send such details is enclosed as **Annexure I**. It is requested that these documents may be sent on the e mail IDs mentioned above at the earliest.

- iii. Every month NIC is organizing various workshops and training programmes. This is intended to facilitate initiation of e-publishing of tender enquiries on the CPP Portal. Ministries/Departments which have not yet nominated participants for training in e-publishing are listed at **Annexure II**. Action may be taken to nominate representatives to attend the ongoing training programs as per schedule published on the CPP portal.
 - iv. Some Ministries/Departments have not yet appointed Nodal officers and have not got User IDs and Passwords issued from NIC for accessing the portal. List of Ministries/Departments which have not yet nominated suitable Nodal officer to coordinate the implementation of the project is at **Annexure III**. In all such cases it may be ensured that the Nodal officers are appointed immediately.
 - v. As brought out in OM dated 5th March 2012, many Ministries/Departments and CPSE's are still not mentioning the CPP portal in their notices for inviting tenders published in the newspapers. Since the CPP Portal is intended to be a comprehensive portal in which **all** Notice Inviting Tenders (NIT) are reflected, the same may be mentioned in the advertisements pertaining to NIT appearing in the newspapers and ensuring that such tender enquiries are also simultaneously published on the CPP Portal.
3. It is requested that instructions on the above may be issued at your end to the Ministry/Department and all subordinate and attached offices under your charge. Problems if any, being faced in e- publishing tender enquiries and other details on the CPP Portal may be reported at the e-mail id cPPP-nic@nic.in .
