It facilitates :

ePublishing - Publishing of tender enquiries, corrigendum & award of contract details.

XML - Facilitates publishing of tender comprehensive information of other eProcurement system.

eProcurement - Facilitated through - GePNIC® implemented in 706 around Central Government Ministries / Departments and Public Sector Units, it is also being rolled out across India in 31 State Government / Union Territories.

GFR Rule 151 : Debarment from bidding

(i) A bidder shall be debarred if he has been convicted of an offence -

(a) under the Prevention of Corruption Act, 1988; or

(b) the Indian Penal Code or any other law for the time being in force, for causing any loss of life or property or causing a threat to public health as part of execution of a public procurement contract.

(ii) A bidder debarred under sub-section (i) or any successor of the bidder shall not be eligible to participate in a procurement process of any procuring entity for a period not exceeding three years commencing from the date of debarment.

(iii) A procuring entity may debar a bidder or any of its successors, from participating in any procurement process undertaken by it, for a period not exceeding two years, if it determines that the bidder has breached the code of integrity.

(iv) The bidder shall not be debarred unless such bidder has been given a reasonable opportunity to represent against such debarment
