CENTRAL PUBLIC PROCUREMENT PORTAL (CPPP)

Central Public Procurement Portal provides a single point access to all the tendering information on various procurement made across the country. It is integrated with Government eMarketplace and is called as GeM-CPPP. It hosts the Government eProcurement System (GePNIC[®]) for electronic procurement developed by National Informatics Centre in close coordination with Department of Expenditure, Ministry of Finance.

Facilitates publishing the metadata of tenders published by organisations using varied eProcurement System.

Odisha Government e-Procurement System

The Odisha e-Procurement Portal is a comprehensive digital platform designed to manage and streamline the entire public procurement process for Government of Odisha departments, ensuring transparency, efficiency, and accountability in tendering activities. Since its inception, the portal has facilitated 5,47,031 tenders with a cumulative value of ₹5,97,080.5 crore, reflecting its critical role in supporting state-level infrastructure development, public works, and service procurement. By enabling end-to-end electronic tendering—from bid publication to award of contract—the platform strengthens fair and competitive bidding, enhances ease of participation for bidders, and supports the Government of Odisha's broader digital governance.

KEY ACTS / RULES / MANUALS & GUIDELINES

1. Odisha General Financial Rules (OGFR), 2023: OGFR, 2023 is the primary rulebook governing all public procurement in Odisha. It mandates transparency, competition, fairness, and economy, and allows procurement through authorized e-procurement platforms like the Odisha e-Tender Portal.

2. Mandatory Use of Authorized e-Procurement Portal: As per OGFR, procurement of goods, works, and services above prescribed limits must be carried out through open tendering or authorised electronic platforms, including tendersodisha.gov.in.

3. Government of Odisha e-Procurement Guidelines / Office Memoranda: The State Government issues departmental circulars and Office Memoranda (Works Department / Finance Department) that operationalize e-procurement, covering bid submission, opening, evaluation, and system procedures on the portal.

4. Information Technology Act, 2000: The IT Act, 2000 provides legal validity to electronic records and digital signatures, making online bid submission, bid opening, and electronic communication legally enforceable.

5. Mandatory Digital Signature Certificate (DSC): Bidders must use a valid Class-III Digital Signature Certificate to access and submit bids on the Odisha e-Procurement Portal, ensuring authenticity and non-repudiation.

6. Tender-Specific Conditions (DTCN / NIT): Each tender published on the portal includes Detailed Tender Call Notice (DTCN) or NIT, which binds bidders to comply with OGFR, government orders, portal terms, EMD rules, bid validity, and evaluation procedures.

HIGHLIGHT OF THE MONTH

LAUNCH OF NEW GEPNIC (e-TENDER) PLATFORM FOR GOVT. OF WEST BENGAL

for APAS (Amader Para Amar Samadhan) and Pathashree Schemes

Govt of **West Begal** has launched a flagship infrastructure projects “**Amader Para Amader Samadhan**” (APAS) and “**Pathashree Schemes**” for improving the rural infrastructure. To implement the schemes under the supervision of Panchyat and Rural Development Department, Government of West Bengal, several purchasing authorities are required to utilize the electronic tender portal which leads to increase the traffic volume in the system.

Under this scheme the expected load is perceived to increase from existing capacity of 400 tenders to 1000 tenders in each hour spanning across 9:00 AM to 6.50 PM

NIC eProcurement Division has achieved a major milestone by setting up a second instance of GePNIC in the West Bengal State Data Centre to manage the growing volume of electronic tenders. This was accomplished in an exceptional combined efforts of all eProcurement Software Development Implementation Division NIC, NIC HQs, and NIC eProcurement along with the Finance Department, GoWB and the WBSDC.
